



## **MEMORANDUM OF UNDERSTANDING**

**BETWEEN**

**KHMELNYTSKYI NATIONAL UNIVERSITY  
UKRAINE  
and  
NAMANGAN STATE UNIVERSITY  
Uzbekistan**

Khmelnytskyi National University, Ukraine, and Namangan State University, Uzbekistan, for the purpose of increasing educational, scientific, and cultural possibilities, promotion of educational exchanges and international cooperation, agreed on the following:

### **1. OBJECTIVES OF COOPERATION:**

- 1.1. Establishing of mutually advantageous educational, scientific, and cultural relations between the educational institutions.
- 1.2. Developing of relations between academic staff, students, individual scientists, and professors of the educational institutions.
- 1.3. Promotion of integration process of the universities into the world educational and scientific space.

### **2. TASKS OF COOPERATION**

#### **2.1. In the field of educational activity:**

- 2.1.1. Experience exchange in the organization of educational process and methods of teaching.
- 2.1.2. Exchange of invitations for participation in scientific and methodical conferences and workshops held at the educational institutions.
- 2.1.3. Exchange of academic curricula, scientific literature, and program packages.
- 2.1.4. Academic staff exchange.
- 2.1.5. Students exchange.
- 2.1.6. Joint preparing and publishing of the educational textbooks and tutorials.

#### **2.2. In the field of scientific activity:**

- 2.2.1. Exchange of invitations for participation in scientific and practical conferences and workshops including students conferences.
- 2.2.2. Preparation and publishing of joint scientific works.
- 2.2.3. Bilateral scientific internships of academic staff, undergraduate and postgraduate students.
- 2.2.4. Participation in the preparation and fulfillment of joint scientific projects, as well as the projects conducted in the frames of intergovernmental programs and international grants.





2.2.5. Exchange of scholarly literature published by the academic staff of the educational institutions.

**2.3. In the field of administration:**

2.3.1 Mutual visits of administration representatives from both educational institutions for consultations, coordination of agreement conditions, and experience exchange in the field of higher educational institution management.

**3. ORDER OF THE CHANGE AND CANCELLATION OF AGREEMENT**

3.1. Changes can be implemented into the agreement on the basis of the written consent of the both sides.

3.2. In the case of unilateral cancellation of the agreement the side is obliged to inform about it in the written form not later than 6 months before the cancellation.

**4. TERMS OF AGREEMENT ACTION**

4.1. Agreement is signed for five years.

4.2. The period of agreement validity can be prolonged under the mutual consent of both educational institutions.

**5. AGREEMENT CONFIRMATION**

5.1. Agreement comes into action from the moment of its signing by both sides.

5.2. Agreement is drawn up in 2 copies in the English language, which have equal legal effect.
